Third JAFE Executive Seminar held on Oct.31, 2014

The third JAFE Executive Seminar was held with the guest speaker, Mr. Yasuchika Hasegawa, Chairman of Keizai Doyukai (Japan Association of Corporate Executives) and Representative Director, Chairman of the Board & CEO of Takeda Pharmaceutical Co., Ltd. Following Mr. Hakubun Shimomura (Minister of Education, Culture, Sports, Science and Technology) and Ms. Atsuko Muraki (Vice Minister of Health, Labour and Welfare), who delivered a speech at the first and second JAFE Executive Seminars respectively, Mr. Hasegawa, the first speaker from the business community, gave a lecture with the title of "The Age of Women Has Come at Last."





Excerpts from Mr. Yasuchika Hasegawa 's Address at the Executive Seminar



- Since the beginning of the human history, attributes that characterize the male gender—power, speed, and spatial/position recognition abilities—have been considered important to achieve the goal of continued survival of a family and tribe. As an inevitable result, human societies have been historically male-dominated. However, such attributes are scarcely necessary in this modern era with highly developed civilization and sophisticated technologies. Now we need to accelerate the momentum of change by raising the awareness of men who still hold advantageous positions given that a significant amount of time would be necessary to rebuild the long-established social structure.
- Of all creatures on the earth, only human beings possess the ability to set goals and make efforts to achieve them. Those who can achieve their goals are those who are not discouraged by repeated failures and continue their efforts.
- It is said that the keywords for corporate management in the 21st century are globalization, innovation, and diversity. Nations and corporations must establish a highly diversified organization to catch up with the increasingly accelerating globalization.
- The Abe administration is focused on the women empowerment as the core of its economic growth strategies. It is fully determined to achieve the goal by implementing specific measures such as upgrading child care/housekeeping support systems, developing a work environment that accelerates the promotion of female personnel, establishing a taxation system that is neutral to any working style, reviewing the social security systems, and introducing flexible ways of working.
- I strongly believe that the advancement of women will rapidly gain momentum although the start was somewhat slow. At last, the age of women has come. We male executives will also endeavor to reach a watershed moment, through which we can enter a new phase of history where more women are involved in management and promoted to managerial positions.
