Mr. Saiki spoke on the theme of "Challenges for Japan's Diplomacy," explaining various challenges facing Japan, including their backgrounds, in a detailed and easy-to-understand manner.

### Excerpt from Vice-Minister for Foreign Affairs Akitaka Saiki's Address at the Executive Seminar



### Domestic politics and diplomacy are closely intertwined

(1)Peace and security legislation: The enactment of this legislation has great significance that is directly linked to Japan's security and defense policy. It has a great impact on Japan's external relations and how it is viewed by neighboring countries.(2)Relocation of the Futenma base: The central government and Okinawa remain sharply divided. At the same time, however, as we must keep our promise to our key ally, the United States, this is a matter that has significant bearing on the very foundation for mutual trust between the two countries.(3)Abductions of Japanese citizens by North Korea: Since 2002 when then Prime Minister Junichiro Koizumi visited North Korea, the Japanese government—despite changes in the political leadership—has been consistently working toward solving this problem in order to protect the lives and properties of its people.(4)Trans-Pacific Partnership (TPP): With each country having its strengths and weaknesses, efforts are being made to coordinate conflicting interests so as to reach agreement in such a way that each country will have some wins to bring home and explain to its people.

### Shifting power balance

(1)Russia: Russian President Vladimir Putin has very high approval ratings in Russia. Although Russia has been facing an economic crisis due to Western sanctions over the Crimean issue, President Putin's hardline foreign policy remains intact.(2)China: President Xi Jinping has been pursuing high-handed

diplomacy similar to that of Russia, for instance, by advocating for the "Chinese dream," in which he is linking people's sense of rivalry against the United States, Europe, and Japan to nationalism.(3)Middle and Near East: Syrian refugees are flowing into Germany and other European countries. Due to the expansion of Islamic State, the governments of Middle East countries are paralyzed.(4)International organizations: The Chinese economy has a significant impact as seen in the expansion of the Group of Seven (G7) into the Group of Twenty (G20) and the establishment of the Asian Infrastructure Investment Bank (AIIB), an international financial institution led by China, as a counter-power to the existing international financial regime led by the World Bank and the International Monetary Fund (IMF).

### Cooperation to developing economies
